10. All suppliers such as drink trucks, bread trucks, etc. are required to purchase gate passes for all employees and to purchase vehicle passes before entering the grounds. Vehicle passes are available at the Stampede Office and must be picked up prior to July 21, 2011. One vehicle pass is permitted per Exhibitor. Additional vehicle passes must be purchased at a cost of \$50.00.
11. **All OUTDOOR booths must be serviced 11:00 a.m. – 10:00p.m., INDOOR booths must be serviced 11:00 a.m. – 9:00 p.m., UNLESS NOTIFIED BY THE MANAGEMENT OF THE VALLEY AGRICULTURAL SOCIETY.** Service vehicles are to be removed from the grounds during this time. In case of an emergency the Manitoba Stampede & Exhibition management may authorize other deliveries.
12. Undesirable displays or Concessionaires may be removed from the grounds at the discretion of the Manitoba Stampede & Exhibition.
13. The Manitoba Stampede & Exhibition shall be the sole judge of all propriety or impropriety on the part of the Concessionaire or his/her employee.
14. **No contracts will be accepted unless accompanied by payment.**
15. All deposits will be retained.
16. In case of default of full payment, any or all articles, goods, or equipment may be held until full payment is made.
17. The privilege granted is in no way an exclusive privilege.
18. No pets are allowed in the concession areas.
20. Early dismantling of booths will result in privileges being canceled for future years.
21. All Concessionaires must abide by all Provincial Health and Labor Regulations, Town of Morris Bylaws, and the Laws of the Province of Manitoba.
22. All lunch booths, refreshment pavilions, or other stands must be substantial in structure and neat in appearance. Unnecessary obstacles in or around stands that would otherwise deter customers will not be tolerated.
23. Food Concessionaires must be supplied with and sell only wholesome food and pure, honest goods at reasonable prices. All articles of food and drink must be kept under cover before time of service. All concessionaires must comply with the authorized health requirements. There must be a fire extinguisher in each booth. Food concessionaires are asked to submit a menu with this application form. All food and items are subject to approval by management. Unless approved by management, no food item may be given away which is sold elsewhere on the grounds.
24. Concessionaires and their help must be neat and tidy in their dress.
25. The use of a loudspeaker, amplifier, radio, or other sound device must be regulated. The privilege will be revoked should the noise become too loud and complaints received.
26. If we receive an NSF check or the like from Concessionaires, the Manitoba Stampede & Exhibition shall revoke the privilege contract and no consideration will be given for space renewal.
27. **ALL CONCESSIONAIRES MUST ABIDE BY ALL EXCLUSIVITY AGREEMENTS made by the Manitoba Stampede & Exhibition.**
